**EVENT Waiver, Release, Assumption of Risk and Indemnification Agreement**

**READ THIS AGREEMENT COMPLETELY BEFORE SIGNING. BY SIGNING THIS AGREEMENT, YOU RELEASE THE UNIVERSITY FROM ANY LIABILITY RESULTING FROM YOUR PARTICIPATION IN THE ACTIVITIES LISTED BELOW AND WAIVE ALL CLAIMS FOR DAMAGES AGAINST THE UNIVERSITY.**

I intend to participate in the West Elk Bicycle Classic (hereinafter the “Activity”) sponsored by on these dates: September 1, 2019

In consideration of Western State Colorado University making arrangements for and permitting and assisting me to participate in this Activity, I agree, for myself, my heirs and assigns, to hold harmless, release, indemnify and forever discharge Western State Colorado University (the “University”), its board of trustees, officers, directors, employees and agents and any persons acting on their behalf from and against any and all liability, claims, demands, costs and expenses (including attorneys’ fees) arising out of or in any way connected with bodily injury or property damage relating to or arising out of my participation in the Activity even if the liability, claims, demands, costs and expenses may arise, in whole or in part, out of the negligence or carelessness of the persons or entities mentioned above.

I am aware that the Activity may include certain inherent risks and dangers, including but not limited to travel risks. I understand that specific risks vary depending on the level and nature of the Activity, and can range from minor personal injuries such as scratches, bruises, and sprains to major injuries such as eye injuries and back or joint injuries to catastrophic injuries resulting in paralysis or death.

I understand and assume all the dangers and risks associated with this Activity and waive all claims or causes of action arising out of my participation in this Activity. To the best of my knowledge, I am not aware of any mental or physical disability or health-related reasons or problems that would hinder or otherwise prevent me from safely participating in the Activity. I understand that I am solely responsible for any costs arising out of any bodily injury or property damage sustained through or arising from my participation in the Activity.

I further hereby agree to indemnify and hold harmless the Releasees from any loss, liability, damage or costs including court costs and or attorneys’ fees, that they may incur due to my participation in said transportation, whether caused by the negligence of Releasees or otherwise.

This Agreement shall be governed by and in accordance with the laws of the State of Colorado and venue for any action related to this Agreement shall be in the State of Colorado. I expressly agree that this Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Colorado, and that if any portion herein is held to be invalid or unenforceable, the balance shall continue in full legal force and effect. I have carefully read this Agreement, understand the contents herein, and am executing it voluntarily of my own free will. I have had sufficient time to review and seek explanation of the provisions above, have carefully read them, understand them fully and agree to be bound by them.

Nothing in this Agreement shall be construed to waive, limit, or otherwise modify any governmental immunity available to any of the persons or entities released herein under the Colorado Governmental Immunity Act, §24-10-101, et seq., C.R.S.

# **Terms and Conditions**

## **Rules**

1. The course will be marked with Aids dispersed. Please do not turn unless designated to do so. The few side roads will be marked with XX.
2. Helmets are mandatory
3. Rules of the road apply, ride to the right of the center line and obey traffic laws, pick up trash,
4. Be kind to all, be the person your dog thinks you are.
5. No personal audio. Please be aware of your surroundings.
6. The West Elk Bicycle Classic contains steep climbs on gravel at high altitudes. Heat, cold rain, dirt, mud and exhaustion are possibilities. SAG and medical personnel are on course but may take time to reach you. Please plan accordingly. You may drop items in SAG for pick up at the finish.
7. The timed finish is at the top of Kebler Pass. The Beer/food is in the Town Park-Follow Kebler to Whiterock and continue straight to the park.
8. Tandems sign up individually.
9. No Refunds: Cycling is an outdoor activity subject to the elements, we cannot control the weather and the ride goes rain or shine unless deemed too dangerous. An alternate route will be announced if possible. No refunds can or will be issued given the prepaid costs of permitting by 5 agencies, state patrol escorts, medical personnel, merchandise, insurance, food etc. If you cannot ride you may transfer your entry or arrange a pick-up of merchandise.
